# Data Privacy Principles

## TRANSPARENCY

GDPR - art. 5, 12, 13, 14; Recitals 39, 58, 60, 61, 62

To ensure a fair processing of personal data, data privacy laws require you to publicly communicate who you are as a company, information about the data you collect, why, how and for how long you collect it, as well as the data subjects' rights.

## LAWFULNESS OF PROCESSING

GDPR art. 5, 6, 13, 14; Recitals: 39, 40  
Article 29 Working Party  
Guidelines on consent under Regulation 2016/679

As processing of personal data is only possible if you have a lawful basis, you must determine and document yours before collecting any Personally Identifiable Information. Once you're established it, you must make it visible to users and disclose if the information is used for profiling or if it leaves the EU.



## DATA SUBJECTS' RIGHTS

GDPR art. 12-23; recitals: 1, 2, 4, 57, 59, 63, 65, 69, 70, 73, 74, 76, 114

As a data controller, you are obliged by the GDPR to enable data subjects to easily enforce their rights under the data protection law. Therefore, you must put in place appropriate processes to verify their identity and manage the requests in a timely manner.

## ACCOUNTABILITY

GDPR art 5,24; Recitals: 39,74,85

Proving compliance is as important as being compliant. You need to be able to prove that you respected data subjects' rights, addressed their requests and collected consent before performing any processing activity governed by consent.


# Company & DPO Data Management
